Many thanks in advance for your generosity to Plymouth! In order to make your pledge payment or one-time gift, please see the options below for how to issue your gift.

DEBIT / CREDIT CARD

We strongly encourage electronic, recurring gifts! Due to the ongoing postal service delays, combined with processing logistics, setting up your gift on a recurring basis by way of your credit/debit card is a great way to ensure there are no mail carrier delays and that your gift is put to its intended use, specifically. For institutional budgeting purposes, recurring gifts allow us to plan better as an institution our estimated cash flow for the benefit of our congregational, school, and community programs.

To set up your gift via debit/credit card, please go to **plymouthchurch.org/give** to set up your card on the REALM payment platform.

CHECK (via regular mail)

To issue a check, please fill it out as follows:

Please do not put the name of a program or event in the "Payment to" line. This will be rejected by the bank, and the check will need to be voided.

Memo Line: i.e., STEWARDSHIP 2023-24 or THE SPIRIT AT WORK

Please note the Memo line *must be filled in* so that it may be designated to the correct bank account.
