Biographies of Slate Candidates

Josh Pater (Nominated for Church Council)

Josh Pater has been a member since 2011. He was raised in Christian Reformed churches in west Michigan. At Plymouth he has served on the Personnel, Nominating, and Christian Help committees, and as a Lent small group leader. He is an in-house attorney at an accounting firm. He and Jaime have two children, Dashiell and Wilhelmina, who are proud graduates of Plymouth Church School and avid participants in Plymouth's ministry to children.

Laura O'Donnell (Nominated for Church Council)
