

Improved Accessibility for welcome and hospitality of *everyone* (incl. persons who use wheelchairs and	Removal of select pews for improved egress and accessible access
their families)	Increased access in front of sanctuary for more
Increased flexibility for liturgical and musical elements in worship;	flexible and enhanced worship, including improved access to piano
	Motorized French doors at rear of Sanctuary (towards Hillis entrance) for increased accessibility

Center pew removal includes pews: #59 & #60; #129, #130 (NOT the Lincoln Pew!) Areas with removed pews will have new carpet.
